- Supervise and mentor the finance teams of KHPT and also sub-recipients, strengthening capacity in financial management and donor compliance.
- Drive continuous improvement in financial systems, process automation, and internal control mechanisms.
- Liaise with donors to ensure compliance with reporting and audit requirements.
- Coordinate with banks and financial institutions to ensure smooth financial operations.
- Oversee audit and taxation functions to ensure timely and accurate compliance.
