1. Candidates must ensure that they fulfill all eligibility criteria as on the cut-off date.
2. Only Indian Nationals are eligible to apply.
3. The appointment will be on a Fixed-Term Contract (FTC) basis.

5. Reservation and age relaxation for SC/ST/OBC (Non-Creamy Layer)/PwD candidates shall be applicable as per Government of India rules.
6. Candidates are required to bring the duly filled application form in the prescribed format along with original certificates and self-attested copies of all supporting documents for verification, including:

10. Only candidates meeting the prescribed qualification and experience criteria will be permitted to participate in the selection process.
